# Parking management: not just about where to put your car!

Point of Park4SUMP: that parking is key measure to achieve SUMP objectives

- Influence modal split
- Boost local economy
- Cut congestion
- Improve safety
- Improve accessibility
- Improve health



# Parking management tools

More operational... (supports SUMP)

- Setting time limits
- Limiting access to certain groups
- Charging fees / pricing
- Marking areas where parking is prohibited / allowed
- Infrastructure (e.g. bollards)



More strategic (from SUMP...)

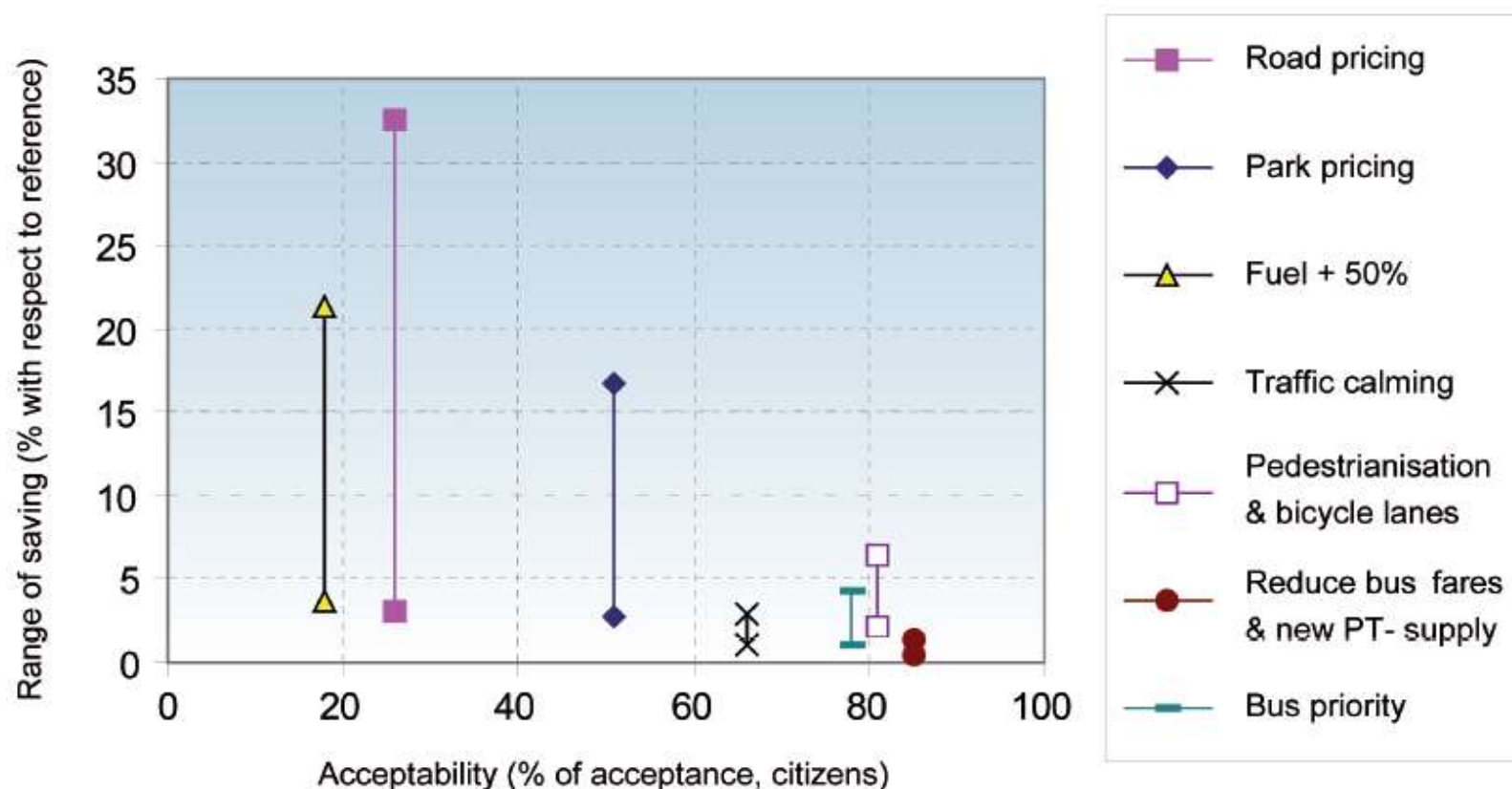
- Changing parking space to other space
- Reducing or limiting supply
- Limiting parking built with new development
- Taxing off-street (currently only in Britain, Australia)





# Parking management – a unique SUMP measure

- Good impact/acceptance ratio
- Only one of 2-3 traffic restraint measures available to most municipalities



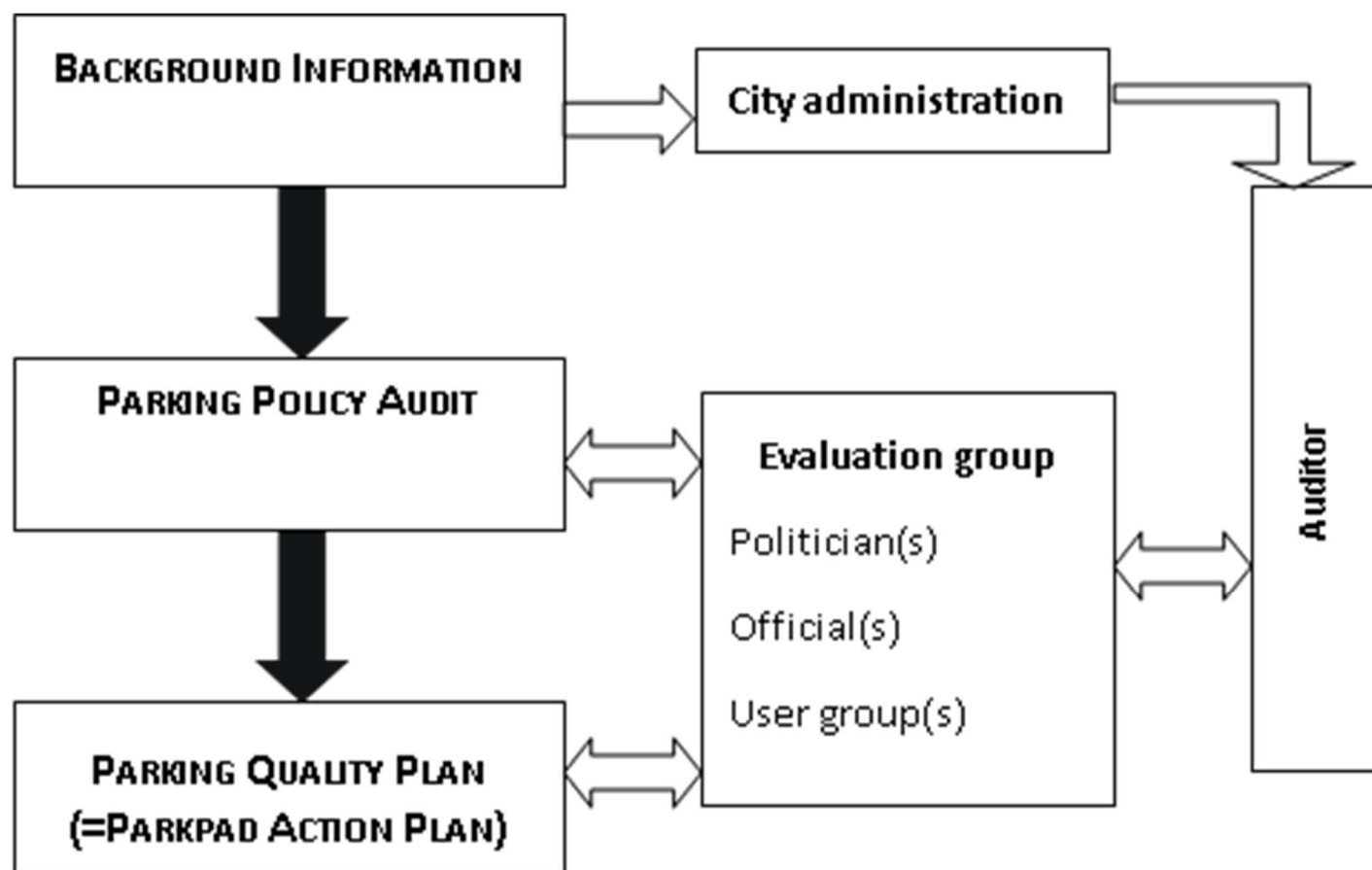

# ParkPAD

# ParkPAD – core part of Park4SUMP

ParkPAD - a tool for city to:

- Review and audit city's parking policies
- achieve consensus on improvements
- develop action plan



# Establish audit group



# Centrepiece of ParkPAD: questionnaire



All members of audit group fill it in before first meeting

14 questions

Examples of topics:

- Parking policy, bike parking policy
- Information, consultation, participation
- Enforcement
- Park and ride
- Loading and unloading

Scored on 5 point scale, guidance given on scores



# First meeting (Consensus meeting)

- Discussion only about disagreements on scores
- Try to reach consensus score for each question
- In total not more than 15 people!!
- Establishes priority areas for action on parking in future

# Meeting 2 – sets outline action plans for priority areas from Meeting 1

## Example - enforcement

<i>Aim</i>	Make enforcement more efficient and effective by handing over this task to a private organisation
<i>content</i>	Checking the law / regulations. Receiving the ok from persons in charge (Politicians / decision makers) Defining the responsibilities and tasks Planning the organisation of operation Developing tender specifications Launch the tender Taking a decision
<i>Responsible person</i>	Mr. Jones
<i>Time frame</i>	From now on – within 6 months



# Real benefits of actual audits

- Strengthens focus on parking management
- Brings parking stakeholders together - unusual
- Agreement on what is good, what is less good
- Set priorities for improvement
- Less advanced city I helped, areas for improvement:
  - Use of public space by parking
  - Poor enforcement
  - Involving people in parking policy
  - Parking standards in new development
  - Expanding parking controls to new areas
- More advanced city
  - Curiously – many of same priorities!
  - Also distribution of and criteria for residents' parking permits

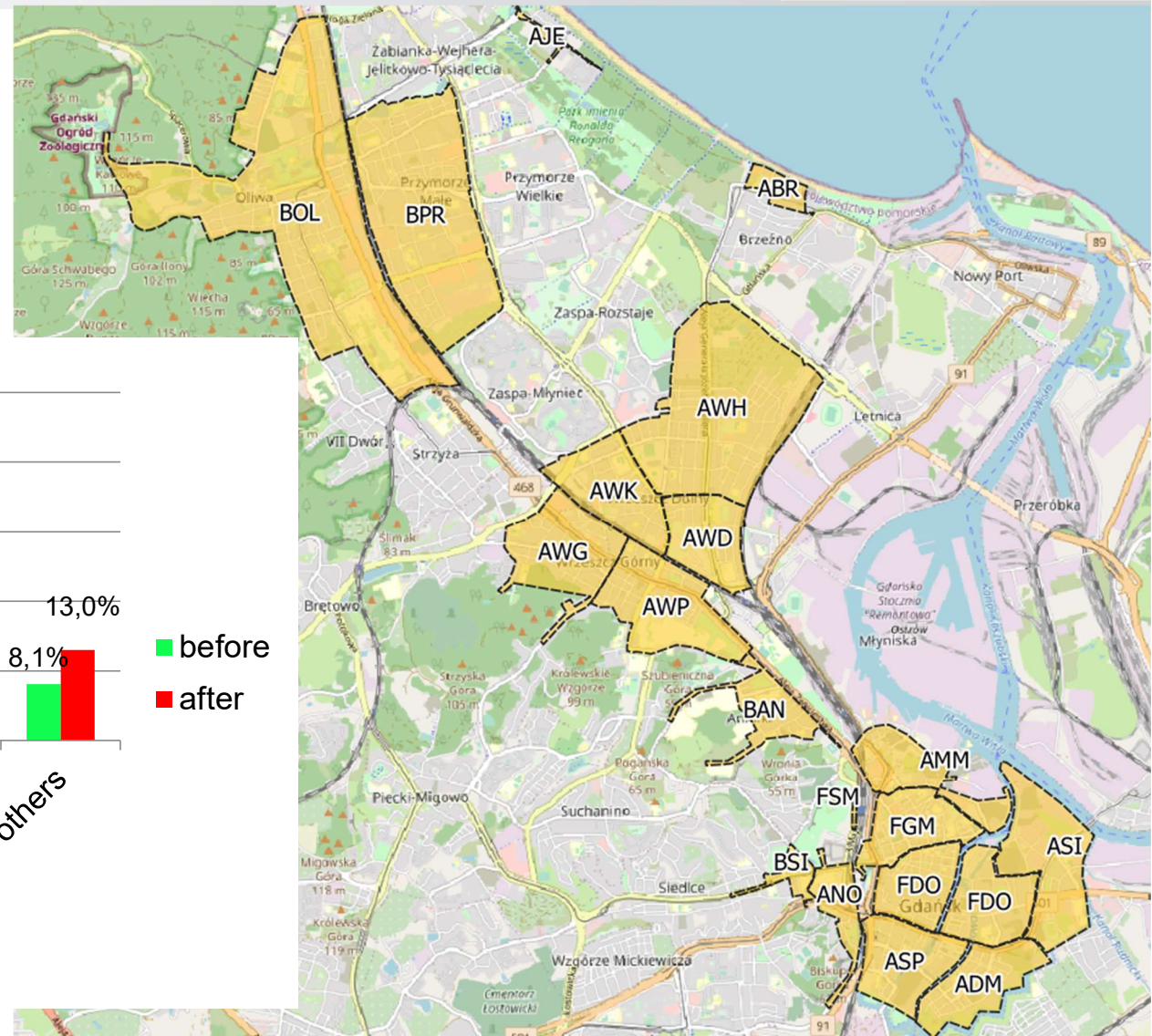
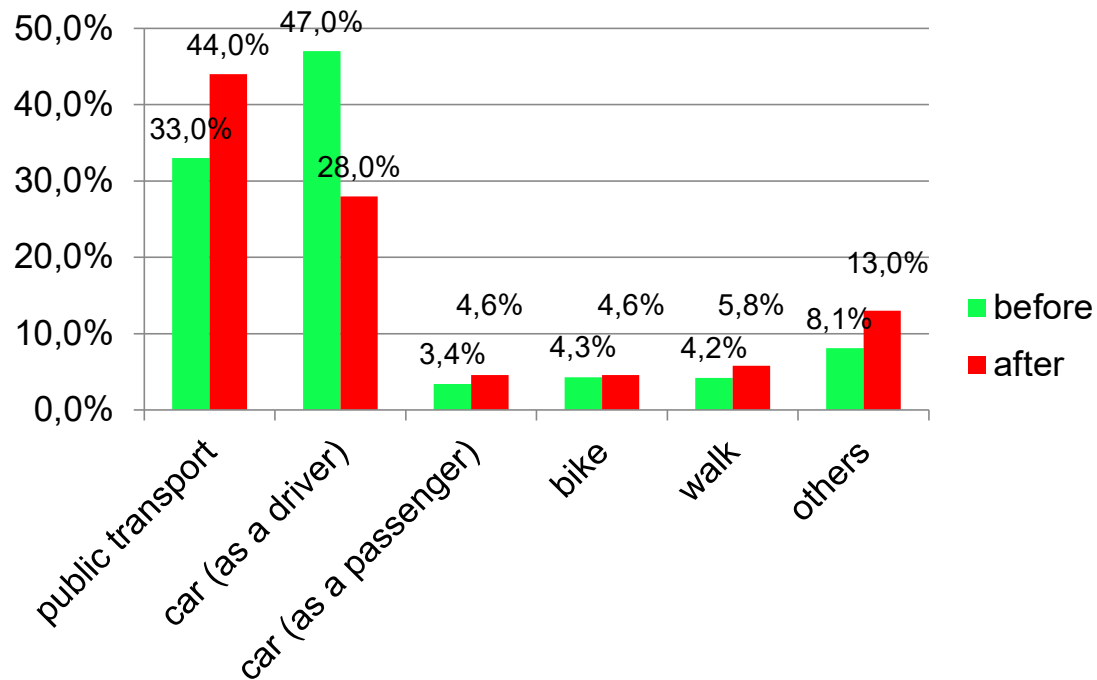

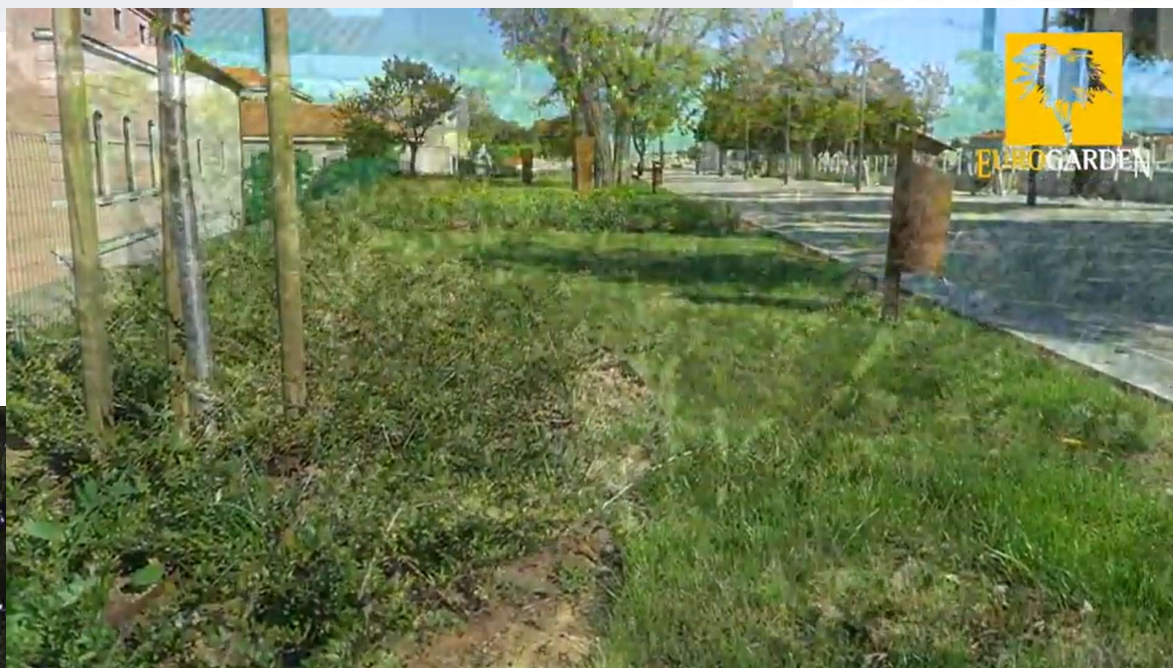
# Regular increase in size of controlled zone

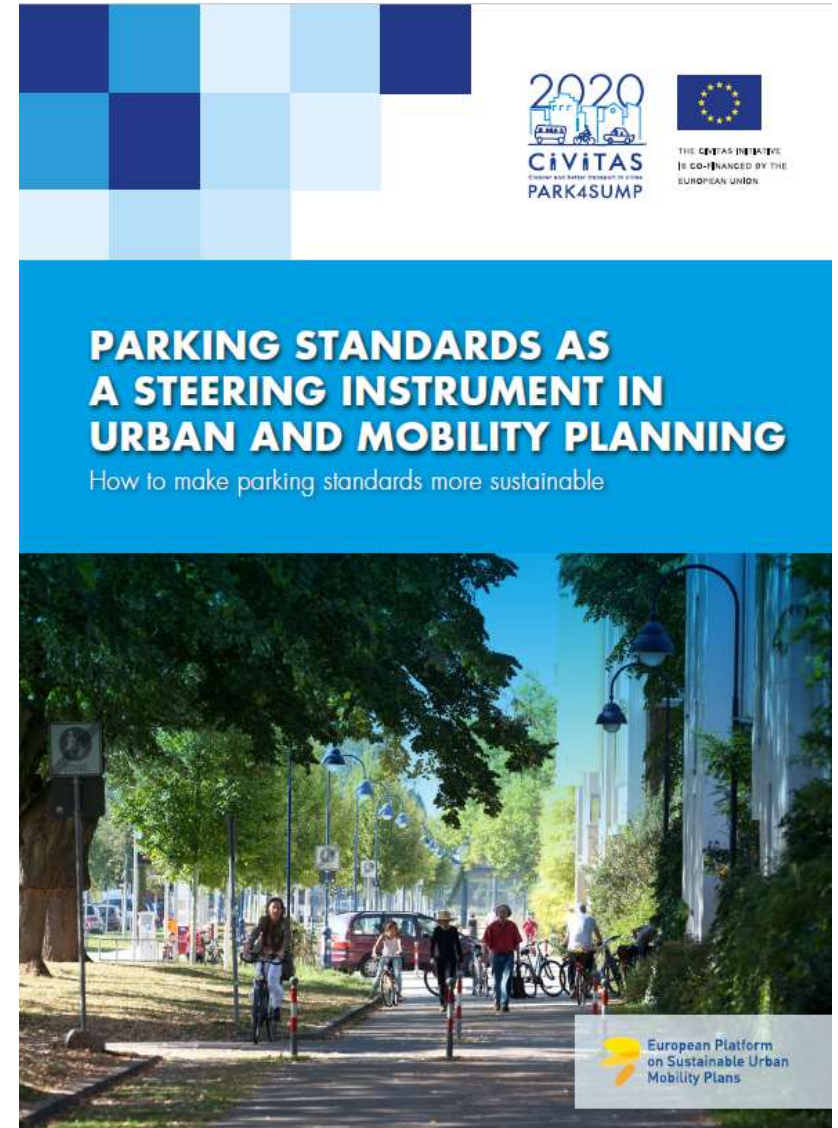

# Reducing supply with parking standards – Freiburg, Oxford



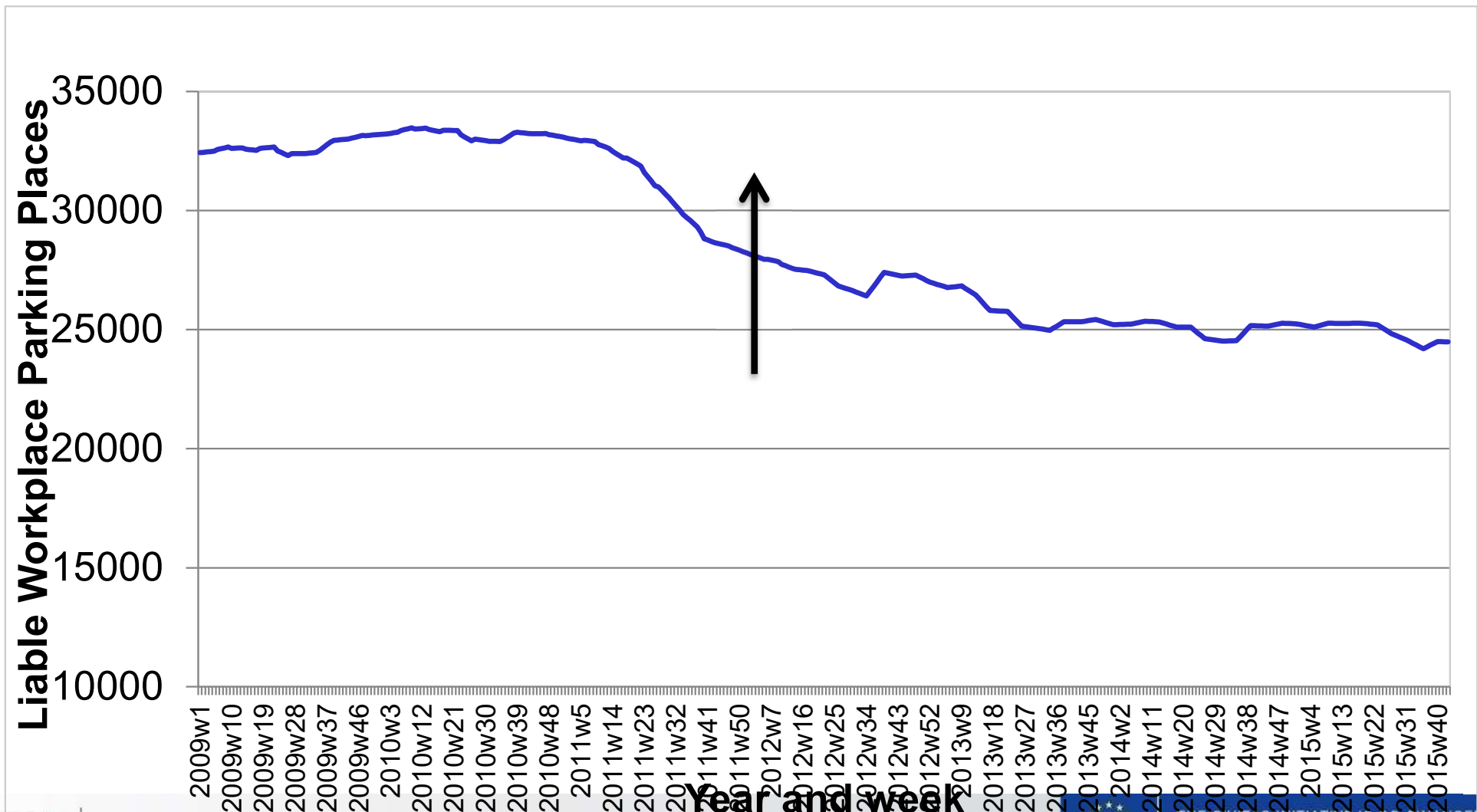
- Freiburg (DE) – more flexible parking standards with more maxima
- Oxford (GB) – over years, used maximum parking standards to reduce parking in new buildings – fundamental in cutting car use in city centre





## Taxing private off-street

Nottingham, England – tax on employer-provided staff parking off-street, 500€/yr – introduced 2011



## Recycling revenues – financially and organisationally

- ✓ PL new regulation – **at least 65% of income from fees** has to be spent by municipality **ONLY** on improvements in sustainable transport and green areas
- ✓ Regulation applies to **100% of income from fines**
- ✓ Higher level of fees should lead to **increase of economic efficiency of off-street parking** – leading to new developments and therefore reductions of on-street parking
